Children & Youth – Robert Sirovina, Jr. (434)

See attached report submitted by Robert Sirovina, Jr. (434). Highlights below:

• We are waiting for our shipment of 1,000 ALF dogs.

- ALF donation should be \$12.00 going forward which will include shipping. We are using the shipping program with the Auxiliary.
- Allen Watry knows of a soldier who has recently deployed. He has 2 children and they were sent for the kids.
- John L'Huillier child welfare fund. Trying to raise \$1.00 per member for this fund. Allen At Fall DEC, a list was passed by State that shows Wisconsin has no grants for this. Would be a wonderful program for Wisconsin. Various other opportunities to help children and welfare programming.

National Security – John Hoeft II (234)

- Steve DuBois taking care of our troops in the field. Contact your local congressman to continue support for Camp American Legion.
- Legion supporting a bill to support emergency services in rural communities.
- Suicide prevention over 6000 veterans/year. Be The One program bracelet's are available to call attention to this.
- 118th Congress Pack Act and Burn Pits signed into law August, 2022. Expands service and benefits. No deadline for claiming benefits. Although the deadline for back pay has passed.
- Legion working to provide good living conditions for soldiers and sailors. Includes attention to daycare issues.
- VA continues to modernize health records.
- Allen Watry Legion has various awards for emergency workers. Police, Firefighters, etc.
- There are many National Security concerns both inside and outside our borders at this time. Be vigilant

Veteran's Affairs & Rehabilitation – William R. Olcott (258)

- Bill Olcott He is new to this role and welcomes input.
- Some rumors about VA closing some facilities. Although Bill has not found any listed. They are having trouble recovering nurses due to the pandemic.
- Volunteer opportunities are opening again and are needed.
- Access to care long wait times are concerning. Help build a library of books to waiting areas.
- Rehabilitation what resources are/are not available via VA? Rural residents find what they can at a local clinic. But not all services may be available. Be aware of the difference between Urgent Care and Emergency Care. Funding/reimbursement can be different.
- Most communities do have alcohol and drug counseling available.
- Housing assistance may also be available in your area. Varies by community.
- Dave Fuller distributed flyers for Troop and Family Support. Dave recently signed up a dual member. But found the process more difficult. Member did not have his DD214. Department was able to secure for him. Make sure all veterans are signed up/in with their county service officer.
- Allen Watry we have the opportunity to have Reps and Deps at nursing homes/hospitals.
- Honor Flight and Vets Roll continues to look for participants.
- Randy Timms spoke about the NNOK Ride The Terrence Sund Fund (Unclaimed Veteran Burial Fund) A first of its kind in that all four family units in District 1 are participating.
- Mike Pook must encourage all members to participate. ALL volunteer hours count on the CSR form. Keep track of all activities by all squadron members. Suggest you do this at monthly meetings.
- Fund raising is it proper to hold on to great sums of money? Chris Dannenmann Tax code does have stipulations of what can be carried forward. Best to find veteran causes to donate to.

Finance Commission – Tom Petrie (189). The Finance Commission met on October 21, 2023 at 11:50 am and the report is as follows:

- Tom no numbers are available today. However, it would appear the funds for the 100% membership pins should be available.
- On the reimbursement form, an explanation of who is eligible for what reimbursement is on the back of the form.

Legislative – Steven R. DuBois (143)

- Several issues already discussed under national security. TAP program (Transition Assistance Program) being worked on by National. Helping veterans find employment in a field for which they worked while in the military. 70% of veterans are not completing this application.
- Coast Guard, TSA and Border Patrol are not covered under the funding during a government shut down. Contact your congressman to ask them to include these agencies in funding. See attached report.

Membership – David Fuller (209)

- David Faust updated Reports are available on the SAL website. They are weekly reports. Typically uploaded on Thursday night.
- David Faust ran through the web site and explained the various features.
- David Fuller developing a Membership/Recruitment tool that can be used at remote locations and will explain all aspects of the Legion families. Will run off a flash drive and a smart TV in a box. Will be given to Vice Commanders for use within their regions.
- John Michaels is leaving Department to return to teaching.
- Allen Watry since we are now able to renew online, department is working on a method to return dues to the squadron. They will submit a proposal. Looking at the balance (per squadron) held quarterly. If it's \$50.00 or more, they will send a check. By year end, all accounts will be distributed. - Web has new squadron starter forms. Please review the web site as it has much to offer many of the forms are fillable now. Various questions about starting a new squadron.
