- Development of a process for people to inquire about becoming a SAL Member via the Department and Detachment Web Site Stretch Goal allow on-line sign-up.

Engagement/Visibility – which will be the key to driving Membership Goals

- SAL DEC representation as ALL Legion District Meetings (Spring and Fall)
- SAL Representation at ALL Legion Midwinter and Convention Committee Meetings
- Continued Quarterly Detachment Newsletters more Squadron articles and Upcoming Events
- Foster improved Legion/Squadron coordination at all levels we are a program at all levels, need to be just like other programs (Baseball, Badger Boys, Oratorical
- Foster improved Legion/SAL coordination between common Committees (Americanism, Children & Youth, National Security, Veteran Affairs and Rehabilitation, Finance, Public Relations).
- Creating more avenues of recognition of Squadron activities/Squadron Members from the Detachment. (need more celebration/recognition to drive awareness and engagement).
  - Recognition at State Level (Certificates, articles in Department/Detachment newsletters, other)
  - o Foster inclusion of articles in National Publications
- Engagement of Local Squadrons on Mid-Winter and Summer Convention.
- 100% updated Squadron Information Forms
- 100% submissions of Consolidated Squadron Report.
