There was a roundtable discussion on activities from several squadrons in attendance.

Squadron 294 Hartland is donating a new flag to the school, which has a 3 x 5 flag on large pole. The Squadron is donating size appropriate flag. May $30 - June 2^{nd} - they$ are sponsoring the Wall that Heals. It will be displayed and attended to 24 hours / day.

Several squadrons reported on planned Memorial Day activities which often included partnering with local Scout troops for assistance in placing the flags at cemeteries prior to Memorial Day. A common theme included parades and community activities.

Oak Creek – 3rd Year working with City of Oak Creek to hold a flag disposal ceremony in June on Flag Day. Detachment Chaplain John L'Huillier will give the keynote speech. Honor guard doing volley. Child Welfare Foundation donations are due by May 31st to count for the '23-'24 year.

Squadron 375 reports on the \$1,000.00 scholarship they give for someone obtaining training related to being a first responder. If that person continues their education the following year, the Squadron will give another \$1,000.00 towards that.

Badger Youth Camp – this year starts on June 22, 2024 and is expanded to five days. Donations made to Badger Youth Camp totaled \$5,525.00 recently. It costs \$225.00 to send a kid to the camp, which is put on by the Wisconsin National Guard and is open to children who depend on a service members. It creates connections to other military children in the community. Looking to get 200 youth to attend. There can be some difficult

moments for children who have lost their service member. The Detachment will have several representatives at this again.

Squadron 294 Hartland has also provided assistance to getting similar events started in Hubertus, Orfordsville, Fond du Lac, and La Crosse.
